TREATMENT AT THE CLINIC INCLUDES PRIMARY CARE, ACCESS TO APPROXIMATELY A DOZEN SPECIALTIES, BLOOD TESTS, IMAGING, FLU SHOTS AND OTHER VACCINATIONS. PATIENTS WHO NEED SPECIALTY CARE OUTSIDE OF THE CLINIC ARE AIDED BY A PATIENT NAVIGATOR WHO HAS ACCESS TO A NETWORK OF PARTNER AGENCIES (CATHOLIC CHARITIES AND THE PRIMARY CARE COALITION), ENABLING ALMOST ALL PATIENTS TO OBTAIN THE COMPLEX SPECIALTY CARE OR SURGERY THEY NEED. PATIENTS ARE ALSO REFERRED TO PARTNER ORGANIZATIONS FOR X-RAYS, MRIS, MAMMOGRAMS AND COLONOSCOPIES. THE MEDICAL PROGRAM SERVED APPROXIMATELY 2,200 PATIENTS IN 2020.

PATIENT COMPLIANCE WITH TAKING MEDICATIONS IS ENHANCED BY HAVING A PHARMACY, STAFF AND PHARMACISTS ON SITE. THE CLINIC DISTRIBUTED MORE THAN A MILLION DOLLARS IN MEDICATIONS TO PATIENTS IN 2020. PATIENTS ON FIVE OR MORE MEDICATIONS ALSO RECEIVE INDIVIDUAL MEDICATION THERAPY MANAGEMENT COUNSELING AT THE CLINIC.
